

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

BRAEMAR HILL PEDESTRIAN LINK

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. HWDEN173A-GZ0001, HWDEN173A-GZ0002 and HWDEN173A-GZ0003 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of pedestrian subway connecting the lift tower at King's Road in (ii) to MTR Fortress Hill Station;
- (ii) construction of pedestrian subway plant room, pedestrian subway emergency exit, covered footpath, lift tower with two lifts, platforms for emergency opening with gates and elevated covered pedestrian walkway at King's Road;
- (iii) construction of covered footpaths, lift tower with two lifts, elevated covered pedestrian walkway, footpath, covered staircases, covered staircase with associated stairlift, covered escalator and carriageway between Fortress Hill Road and Tin Hau Temple Road;
- (iv) construction of elevated covered pedestrian walkway across Tin Hau Temple Road;
- (v) construction of covered footpaths and covered escalators at Wan Tin Path;
- (vi) demolition and conversion of the existing maintenance access with associated stairlift near Fortress Metro Tower into staircase;
- (vii) permanent closure and conversion of a section of the existing covered staircase near Fortress Metro Tower into elevated covered pedestrian walkway;
- (viii) permanent closure and conversion of the existing refuge islands at Fortress Hill Road into carriageway;
- (ix) permanent closure and conversion of sections of the existing carriageways at Fortress Hill Road into footpaths, pedestrian crossing, refuge islands and run-in/run-out;
- (x) permanent closure and conversion of sections of the existing footpath at Fortress Hill Road into carriageway and pedestrian crossing;
- (xi) permanent closure and conversion of the existing pedestrian crossings at Fortress Hill Road into carriageway and footpath;
- (xii) permanent closure and conversion of sections of the existing staircase between Fortress Hill Road and Tin Hau Temple Road into covered footpath and footpath;
- (xiii) permanent closure and demolition of a section of the existing staircase between Fortress Hill Road and Tin Hau Temple Road;
- (xiv) permanent closure and conversion of the existing pedestrian crossings at Cloud View Road into footpaths;
- (xv) permanent closure and conversion of sections of the existing footpaths at Cloud View Road into signalized pedestrian crossings;
- (xvi) permanent closure and conversion of sections of the existing verge areas at Wan Tin Path into covered footpaths and covered staircases with associated stairlifts;
- (xvii) permanent closure and conversion of sections of the existing footpath at Wan Tin Path into covered escalators and covered travellers;
- (xviii) permanent closure and conversion of sections of the existing staircases at Wan Tin Path into covered footpaths, covered escalators, covered travellers and elevated covered pedestrian walkway;
- (xix) temporary closure and reconstruction of a section of the existing covered staircase near Fortress Metro Tower;

- (xx) temporary closure and conversion of a section of the existing footpath at King's Road into covered footpath;
- (xxi) temporary closure and conversion of a section of the existing staircase between Fortress Hill Road and Tin Hau Temple Road into covered staircase;
- (xxii) temporary closure and conversion of sections of the existing staircases at Wan Tin Path into covered staircases with associated stairlifts;
- (xxiii) temporary closure and conversion of sections of the existing footpath at Wan Tin Path into covered footpaths; and
- (xxiv) ancillary works including geotechnical, electrical and mechanical, drainage, landscaping, public lighting and utilities works, as well as construction of retaining walls.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 27th day of August 2019.

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
