

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. ED/2018/05 Kai Tak Development—Stage 5B Infrastructure Works at the Former North Apron Area**. The works mainly comprise:—

- (a) construction of a section of dual two-lane Road D1 connecting Olympic Avenue;
- (b) construction of single two-lane Road L9 and Road L16, and a single-lane slip road S14;
- (c) construction of a pedestrian subway across Prince Edward Road East;
- (d) construction of an elevated walkway across Kai Tak River;
- (e) renovation of two existing pedestrian subways, and modification and renovation of one existing pedestrian subway; and
- (f) construction of associated footpaths, street lighting, drainage, sewerage, water mains, landscaping, electrical and mechanical works and ancillary works.

The works are scheduled to commence in the fourth quarter of 2019 and will take about 59 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender box situated in the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 23 August 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 23 August 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 23 August 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C (confirmed) under Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (confirmed) under Roads and Drainage Category who also meet the following qualifications and conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving roads and drainage works, with an adjusted contract value of not less than HK\$380 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents; and
- (ii) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving construction of tunnel or pedestrian subway in or outside Hong Kong, within the past 15 years counting from the original date set for the close of tender.

The detailed requirements on the tenderer's qualifications and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (confirmed) for Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 23 July 2019 to Chief Engineer/East(Special Duty), East Development Office, Civil Engineering and Development Department at 12th Floor, Suite1213, Chinachem Golden Plaza, 77 Mody Road, Tsim Sha Tsui East, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Contractors will be liable to have their names removed from the approved list if they fail or refuse to implement an accepted tender.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
