

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1196EM19T—Triennial Term Contract for Maintenance of Heating, Ventilation and Air-conditioning Installations at Unattended Municipal Venues in the New Territories**. The scope of the Works includes maintenance of heating, ventilation and air-conditioning installations at unattended municipal venues in the New Territories of the Government of the Hong Kong Special Administrative Region. The Works is scheduled to commence in January 2020 for expiry in December 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box, situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 9 August 2019. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above in force at any time between 9.00 a.m. and 12.00 noon on Friday, 9 August 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.
