## PHARMACY AND POISONS ORDINANCE (Chapter 138)

## DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance, Chapter 138, Laws of Hong Kong to inquire into the conduct of an authorized seller of poisons, namely Kam Lun Dispensary Co. Ltd., at Ground Floor, Block L, Percival House, 83 Percival Street, Causeway Bay, Hong Kong, has conducted an inquiry on 17 May 2019 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Kam Lun Dispensary Co. Ltd. had been guilty of misconduct in that at the material time, Kam Lun Dispensary Co. Ltd., an authorized seller of poisons, its director, Mr CHONG Shun-leung, and its employee, Mr CHAN Kam-tim were convicted of the following offences under the Antibiotics Ordinance, Chapter 137, Laws of Hong Kong, the Pharmacy and Poisons Ordinance, and the Pharmacy and Poisons Regulations made under the Pharmacy and Poisons Ordinance on 24 September 2018 at the Eastern Magistrates' Courts for which the following orders were imposed:—

It is further notified that under section 16(2)(b) of the Pharmacy and Poisons Ordinance, the said Committee directed that the Secretary of the Pharmacy and Poisons Board of Hong Kong serve a warning letter on Kam Lun Dispensary Co. Ltd. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
