ELECTORAL AFFAIRS COMMISSION

(Provisional Recommendations on Boundaries and Names of Geographical Constituencies for the 2020 Legislative Council General Election)

Pursuant to section 19 of the Electoral Affairs Commission Ordinance (Chapter 541), notice is hereby given that maps showing the provisional recommendations of the Electoral Affairs Commission ('the Commission') on the boundaries and names of all the proposed geographical constituencies in respect of the 2020 Legislative Council General Election and a document containing descriptions of the proposed geographical constituency boundaries will be made available for public inspection during ordinary business/opening hours from 8 May 2019 (Wednesday) to 6 June 2019 (Thursday), both dates inclusive at the following places:—

- (1) Home Affairs Enquiry Centres of all district offices;
- (2) the Registration and Electoral Office;
- (3) Philatelic Offices of Hongkong Post;
- (4) management offices of all public housing estates; and
- (5) all major and district public libraries of the Leisure and Cultural Services Department.

Besides, the aforesaid maps and descriptions of the proposed geographical constituency boundaries can be viewed from the Commission's website (www.eac.hk).

Notice is also hereby given that representations on the provisional recommendations are invited from members of the public, including any interested organisations. Those who wish to make representations are invited to put them in writing and state on the written representations the name of the person or organisation making them.
