PHARMACY AND POISONS ORDINANCE (Chapter 138)

DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance, Chapter 138, Laws of Hong Kong to inquire into the conduct of an authorized seller of poisons, namely Jackson Pharmacy O/B Wisdom Investment Ltd., at Shop No. 78A, Ground Floor, Tin On House, Shek Yam Road, Kwai Chung, New Territories, has conducted an inquiry on 24 May 2019 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Jackson Pharmacy O/B Wisdom Investment Ltd. had been guilty of misconduct in that at the material time, Wisdom Investment Ltd., operating Jackson Pharmacy, an authorized seller of poisons, its director, Mr FUNG Hei-wang, and its employee, Mr TSUI Tak-shing, were convicted of the following offences under the Trade Descriptions Ordinance, Chapter 362, Laws of Hong Kong, and the Pharmacy and Poisons Regulations, Chapter 138A, Laws of Hong Kong on 10 August 2018 at the West Kowloon Magistrates' Courts for which the following orders were imposed:—
