

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1565EM19T—Triennial Term Contract for the Maintenance, Repair, Alterations, Additions and Improvement for Broadcast Reception Installation and Satellite Master Antenna Television System for the Government of the Hong Kong Special Administrative Region**. The scope of the Works includes maintenance, repair, alterations, additions and improvement for broadcast reception installation and satellite master antenna television system for the Government of the Hong Kong Special Administrative Region. The Contract is scheduled to commence in December 2019 for expiry in November 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor of the Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 23 August 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
