

## PHARMACY AND POISONS ORDINANCE (Chapter 138)

DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF THE  
PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance (Chapter 138, Laws of Hong Kong) to inquire into the conduct of an authorized seller of poisons, namely Wang Tai Dispensary O/B Leader Reliance Limited, at Shop 4, Ground Floor, Kam Luk Building, 71 Shek Yam Road, Kwai Chung, New Territories, has conducted an inquiry on 4 June 2019 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Wang Tai Dispensary O/B Leader Reliance Limited had been guilty of misconduct in that at the material time, Leader Reliance Limited, operating Wang Tai Dispensary, an authorized seller of poisons, and its employee, Mr. LI Kwok-keung, were convicted of the following offences under the Trade Descriptions Ordinance (Chapter 362, Laws of Hong Kong) and the Pharmacy and Poisons Regulations (Chapter 138A, Laws of Hong Kong) on 23 August 2018 at West Kowloon Magistrates' Courts for which the following orders were imposed:—

It is further notified that under section 16(2)(b) of the Pharmacy and Poisons Ordinance, the said Committee directed that the Secretary of the Pharmacy and Poisons Board of Hong Kong should serve a warning letter on Wang Tai Dispensary O/B Leader Reliance Limited. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
