Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on the Amendment Plans Nos. PM/SHT01A and PM/SHT02A and Resumption Plan No. TMM3547c (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which the Amendment Plans and amendment scheme have been deposited in the Land Registry.
