ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

RETROFITTING OF NOISE BARRIERS ON TUEN MUN ROAD  
(FU TEI SECTION)

TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians, verges, cycle tracks, footbridges and vehicular bridge within the limit of works area as shown on Plans Nos. TMR/GZP/101 and TMR/GZP/102 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plan No. TMR/GZP/201 ('the Amendment Plan') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 558 published on 30 January 2014 and 7 February 2014. The Amendment Plan and amendment scheme were referred to in G.N. 5104 published on 5 September 2014 and 12 September 2014. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 10 September 2019 to 9 September 2020, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians, verges, cycle tracks, footbridges and vehicular bridge to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the installation of cantilever noise barriers, vertical noise barriers and semi-enclosures along Tuen Mun Road between the footbridge to Fung Tei Station and Lam Tei Raw Water Pumping Station, and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, central medians, verges, cycle tracks, footbridges and vehicular bridge on 23 August 2019.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
