PROPOSED TRAFFIC IMPROVEMENT MEASURES TO FUI YIU KOK STREET AND TSUEN YIP STREET

TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and emergency vehicular access within the limit of works area as shown on Plan No. HNHADMINS-GZ0024 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 3171 published on 19 May 2017 and 26 May 2017. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 1 September 2019 to 31 August 2020, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and emergency vehicular access to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the widening of the carriageway of Fui Yiu Kok Street; conversion of sections of the existing emergency vehicular access into carriageway and footpaths at Tsuen Yip Street and other ancillary works.
