I am of the opinion that the drains of the building at (address) Nos. 179-181 Queen's Road West, Hong Kong on (Lot No.) I.L.6630, I.L. 6629 are in defective and insanitary condition.

2. In exercise of the powers vested in me by section 28(3) of the Buildings Ordinance, I HEREBY ORDER you as owner to carry out, within a period expiring on the following works:-

For the common underground drainage system of the building at the rear lane only

- (i) Investigate and report on the location and extent of the common defective and ground drainage at the rear lane of the said building, including all defective and misconnected manholes, gullies, surface channels and drainage pipes;
- (ii) Submit proposal for drainage works to remedy the drainage defects and misconnection found in the investigation; and
- (iii) Repair or remedy the drainage defects and misconnection according to the proposal mentioned in (ii) above after it has been accepted by the Building Authority.

(The location of the drainage defects described above is marked on the plan annexed hereto, for the purpose of identification only.)

All works specified in this Order shall be carried out to such standard acceptable to the Building Authority and in compliance with the regulations.


