SCHEDULE

Foreshore and sea-bed affected

Approximately 35 600 square metres of foreshore and sea-bed situated at Kwun Tong Tsai Wan (Yau Tong Bay) as delineated and shown edged red on a plan, numbered KM9656, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- Repair and strengthening of seawalls and construction of new seawalls at Kwun Tong Tsai Wan (Yau Tong Bay), which involve modification, demolition and reconstruction of the existing seawalls and related works.
- Construction of two flights of landing steps along the existing seawall at Kwun Tong Tsai Wan (Yau Tong Bay), which involves modification, demolition and reconstruction of the existing seawalls and related works.
- 3. Erection of a temporary works area at Kwun Tong Tsai Wan (Yau Tong Bay) to facilitate the proposed works in relation to the seawall and landing steps.
