**Volunteer and Naval Volunteer Pensions Ordinance
(Amendment of Schedules) Order 2019**

(Made by the Secretary for Labour and Welfare under section 35(2) of the Volunteer and Naval Volunteer Pensions Ordinance (Cap. 202))

Explanatory Note

This Order amends Schedules 3 to 8 to the Volunteer and Naval Volunteer Pensions Ordinance (Cap. 202) (*Ordinance*) to adjust the rates for the payment of pensions, gratuities and other allowances under the Ordinance in connection with the disablement or death of the officers and volunteers of the Hong Kong Volunteer Defence Corps and members of the Hong Kong Naval Volunteer Force who fought in defence of Hong Kong during the Second World War.

2. The rates are adjusted in accordance with the percentage of increase for the basic pension as declared in the Declaration of Increase in Pensions Notice 2019 (L.N. 72 of 2019) (*Notice*).
3. Under section 35(4) of the Ordinance, the Order is deemed to have taken effect from 1 April 2019 (the effective date for the increase declared in the Notice).
