

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2026EM18T—Quadrennial Term Contract for Provision of Operation, Maintenance and Modification Works for Journey Time Indication System and Hong Kong eTransport Kiosk of Transport Department of the Government of the Hong Kong Special Administrative Region**. The scope of the Works includes provision of operation, maintenance, modification works for Journey Time Indication System and Hong Kong eTransport Kiosk. The Contract is scheduled to commence in December 2019 for expiry in November 2023.

Sealed tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to ‘The Chairman, Public Works Tender Board’ and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon, Friday, 4 October 2019. Tenders must be deposited in the tender box as specified in this tender notice (‘Specified Tender Box’) before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 4 October 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. - (A) Contractor must have completed contract(s) for supply and installation, operation and maintenance or modification works of Vehicle Traffic Detection System or Traffic Control and Surveillance System with an aggregate awarded value not less than HK\$12.8 million within the past 5-year period immediately preceding the Tender Closing Date specified in the letter of invitation to tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement.
