Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan Nos. B811CL-GZS01 to B811CL-GZS03 (the 'Plans') and described in the scheme annexed thereto, which the Plans and the scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:----

- (i) construction of approximately 700 metres of gravity sewers and associated manholes within the limit of works area as shown on the Plans; and
- (ii) ancillary works including temporary closure and reinstatement of carriageways, footpaths, pedestrian crossings and cycle tracks or parts thereof within the limit of works area.

Objectors are required to provide contact details to the Director to facilitate communication.
