

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. ND/2019/02: Kwu Tung North New Development Area, Phase 1: Roads and Drains between Kwu Tung North New Development Area and Shek Wu Hui (Public Works Programme Item Nos. 747CL and 759CL)**. The works mainly comprise:—

- (i) road and drainage works between Kwu Tung North New Development Area and Shek Wu Hui;
- (ii) construction of a sewage pumping station, a visitor centre for Long Valley Nature Park and a footbridge spanning across Sheung Yue River; and
- (iii) site formation of land and the associated engineering infrastructure works for a village resite area in Kwu Tung North New Development Area.

The works are scheduled to commence in February 2020 and will take about 59 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 22 November 2019. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 22 November 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 22 November 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/ or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/ major shareholder in case of a joint venture tenderer, has completed at least one construction contract in or outside Hong Kong involving road and drainage works, with an adjusted contract value of not less than HK\$200 million, within the past 10 years counting from the original date set for the close of tender. The adjusted contract value shall be the awarded contract value being adjusted to current price level as stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 22 October 2019 to Chief Engineer/North 3, North Development Office, Civil Engineering and Development Department at Unit 1501, Level 15, Tower 1, Metroplaza, 223 Hing Fong Road, Kwai Fong, New Territories, Hong Kong, meet the

Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.
