

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2936EM18T, 26-Month Term Contract for Maintenance of Heating, Ventilation and Air-conditioning Installations for Health Sector Venues in Hong Kong Region and Outlying Islands**. The scope of the Works includes repair and maintenance of the air-conditioning installations at health sector venues in Hong Kong region and outlying islands. The Contract is scheduled to commence in April 2020 for expiry in May 2022.

Tenders must submit in triplicate and must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f on the 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 15 November 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 15 November 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.
