

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. HY/2019/09, The Brothers Marine Park—Deployment of Artificial Reef (Public Works Programme Item No. 845TH)**. The contract includes prefabrication of artificial reefs; deployment of artificial reefs in The Brothers Marine Park; and relevant monitoring works before and after deployment of artificial reefs. The contract is scheduled to commence in December 2019 and will take about 40 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box located in Room 4128f on the 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 8 November 2019. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If a black rainstorm warning signal or tropical cyclone signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 8 November 2019, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 8 November 2019, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors not yet on the List of Approved Contractors for Public Works in Group A or B under the Port Works Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 23 October 2019 to Chief Engineer 1/Special Duties, Major Works Project Management Office (Special Duties), Highways Department, 4th Floor, Ho Man Tin Government Offices, 88 Chung Hau Street, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
