## **Explanatory Note**

The Road Traffic (Traffic Control) (Designation of Prohibited and Restricted Zones) Notice (Cap. 374 sub. leg. U) sets out in its Schedules certain prohibited zones and restricted zones in the Hong Kong International Airport. Specifically speaking—

- (a) Schedule 1 sets out prohibited zones in which the driving of certain motor vehicles is prohibited; and
- (b) Part 1 of Schedule 2 sets out restricted zones in which drivers of certain motor vehicles are prohibited from picking up or setting down passengers, or from loading or unloading goods.
- 2. This Notice amends that Schedule 1 to—
  - (a) designate certain areas as prohibited zones (section 3(4)); and
  - (b) vary the designation of certain areas (section 3(1), (2) and (3)).
- 3. This Notice also amends Part 1 of that Schedule 2 to—
  - (a) designate certain areas as restricted zones (section 4(5));
  - (b) vary the designation of certain areas (section 4(1), (2), (3), (4), (6) and (7)); and
  - (c) remove an area from the list of restricted zones (section 4(8)).
