

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 7786CL
TUNG CHUNG NEW TOWN EXTENSION
(ROAD WORKS AT YU TUNG ROAD, CHUNG MUN ROAD, ROAD L29,
ROAD L30 AND SHEK MUN KAP ROAD)

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans No. RD/GZ500/LEGEND and RD/GZ501 to RD/GZ506 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of at-grade carriageways, at-grade footpaths, at-grade cycle tracks, flyovers, elevated footpaths, elevated cycle tracks, at-grade cycle parking areas, at-grade amenity areas, at-grade central reserves/traffic islands, run-ins/run-outs and pedestrian crossings;
- (ii) permanent closure and conversion of sections of the existing at-grade carriageways into at-grade footpaths, elevated footpaths, at-grade cycle parking area, at-grade amenity areas and at-grade central reserves/traffic islands;
- (iii) permanent closure and conversion of sections of the existing at-grade footpaths into at-grade carriageways, at-grade cycle tracks, flyovers, elevated footpaths, elevated cycle track, at-grade cycle parking areas, at-grade amenity areas, staircases, at-grade central reserves/traffic islands and slopes;
- (iv) permanent closure and conversion of sections of the existing at-grade cycle track into at-grade carriageway and at-grade amenity area;
- (v) permanent closure and conversion of a section of the existing flyover into elevated footpath;
- (vi) permanent closure and conversion of sections of the existing footbridge into at-grade footpath, elevated footpath and elevated cycle track;
- (vii) permanent closure and conversion of sections of the existing at-grade amenity areas into at-grade carriageways, at-grade footpaths, at-grade cycle track and slope;
- (viii) permanent closure and conversion of sections of the existing staircase into at-grade footpath, at-grade cycle track and at-grade amenity area;
- (ix) permanent closure and conversion of sections of the existing at-grade central reserves/traffic islands into at-grade carriageways;
- (x) permanent closure and demolition of sections of the existing at-grade carriageways, footbridge, flyover, run-ins/run-outs and pedestrian crossings;
- (xi) temporary closure and reconstruction of sections of the existing at-grade carriageways, at-grade footpaths, at-grade cycle tracks, at-grade amenity areas, staircase and at-grade central reserve/ traffic island;
- (xii) ancillary works including site formation, landscaping, drainage, sewerage, water, street lighting and utilities works, construction of staircases, retaining walls, slopes and noise barrier, and installation of street furniture and traffic aids.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 31st day of December 2019.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
