Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 68.5 hectares of foreshore and sea-bed situated from the southern boundary to the western boundary of the Hong Kong Special Administrative Region (HKSAR) as delineated and shown by a bold red line, a bold blue line and a bold green line on a plan, numbered ISM2902a, deposited in the Land Registry. Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

1. Construction of a double berth jetty supported by piles/jetty structures and its associated facilities (the area of sea-bed affected is approximately 4.9 hectares, of which the jetty footprint accounts for about 2.5 hectares) for the operation of an offshore LNG terminal in the southern waters of the HKSAR, to the east of the Soko Islands.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- 2. Construction of a subsea gas pipeline of approximately 750 millimetres in internal diameter and approximately 45 kilometres in length in the HKSAR waters by dredging/jetting with trench width and armour rock protection varying from about 3 to 29 metres, depending on the construction method, from the jetty to the gas receiving station at the Black Point Power Station.
- 3. Construction of a subsea gas pipeline of approximately 500 millimetres in internal diameter and approximately 18 kilometres in length in the HKSAR waters by dredging/jetting with trench width and armour rock protection varying from about 8 to 29 metres, depending on the construction method, from the jetty to the Lamma Power Station which will be connected to an existing pipeline at around 1 kilometre from the existing seawall of the Lamma Power Station.
- 4. Where any one of the subsea gas pipelines crosses the existing subsea telecommunication cable(s), it will be shallow buried with pipe bridges/concrete mattresses to provide protection to the subsea telecommunication cable(s).

Personal Information Collection Statement
