## PWP CATEGORY D ITEM UNIVERSAL ACCESSIBILITY PROGRAMME—PROVISION OF LIFTS AT FOOTBRIDGE NO. KF69 ACROSS LAI CHI KOK ROAD AND TONKIN STREET IN SHAM SHUI PO DISTRICT

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, bridge decks, staircase and ramp within the limit of works area as shown on Plan No. CE58/GAZ/KF69/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 6601 published on 4 September 2015 and 11 September 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 3 December 2019 to 2 December 2020, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, bridge decks, staircase and ramp to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of three lifts at the existing footbridge No. KF69 across Lai Chi Kok Road and Tonkin Street, the construction of elevated platforms to connect the proposed lifts with the existing footbridge and the car park podium near Lai Huen House and other ancillary works.
