## PWP CATEGORY D ITEM UNIVERSAL ACCESSIBILITY PROGRAMME—PROVISION OF LIFTS AT FOOTBRIDGE NO. HF104 ACROSS ABERDEEN PRAYA ROAD NEAR NAM NING STREET IN SOLITHERN DISTRICT

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and bridge deck within the limit of works area as shown on Plan No. CE58/GAZ/HF104/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2804 published on 17 April 2015 and 24 April 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 3 December 2019 to 31 March 2020, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and bridge deck to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of two lifts at the existing footbridge No. HF104 across Aberdeen Praya Road near Nam Ning Street and Aberdeen Promenade, the construction of elevated platforms to connect the proposed lifts with the existing footbridge and the existing viewing deck of Aberdeen Promenade and other ancillary works.
