NOTICE OF PREQUALIFICATION OF TENDERERS

It is intended to invite tenders from pre-qualified contractors for the provision of the interior design services and the related project management services (collectively known as 'the Services') in case office fitting-out projects/refurbishment and modification works are carried out at the offices of Hong Kong Monetary Authority (HKMA) during the year of 2020–2024. The pre-qualified list of contractors will be valid until end-2024 commencing from the date of the announcement of the result. The contractor who is eventually awarded with the contract(s) will be the Project Manager of relevant office fitting-out/refurbishment and modification works at the HKMA offices.

Applicants with proven experience in the provision of the Services on office fitting-out/refurbishment and modification works, and have provided similar Services for at least two completed or on-going office fitting-out/refurbishment contracts of value not less than HK\$5 million each in Hong Kong within the past 10 years are invited to submit pre-qualification application.

Applicants must submit the completed pre-qualification applications (six identical copies) in sealed envelope which should be marked clearly with the subject 'Provision of Interior Design and Project Management Services—Pre-qualification Document Reference No. GR/3-55/3(19)' on the outside of the envelopes. The envelopes should not bear any indication which may relate the tender to the tenderer. The applications should be addressed to the Tender Box of the HKMA, and delivered by hand to the Reception of the following address not later than 12.00 noon on 18 December 2019 (Wednesday). Late or incomplete application will not be accepted.

The pre-qualification document is now available for collection from the Reception Counter at the above address. Applicants are requested to leave the HKMA with their business cards, or an authorisation letter, when collecting the pre-qualification document.

If tropical cyclone signal No. 8 or above is hoisted, or black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on the closing date for receipt of prequalification application, the closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force.
