

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. RF J503—Design and Construction of Provision of Heated Pool at the Pao Yue Kong Swimming Pool Complex in the Southern District (Programme No. 295RS)**.

The works include design, modification of existing secondary swimming pool into new indoor heated swimming pool, construction of a new annex building, provision of a covered passageway and space heating in existing changing rooms and toilets, together with associated building services installations, drainage and external works. The total net operational floor area is approximately 1 800 square metres. The site area is approximately 15 900 square metres. The contract is scheduled to commence in 3rd quarter 2020 and for completion in 2nd quarter 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 7 February 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 7 February 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 7 February 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C for Buildings Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the above-mentioned approved list/category/group who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (a) The contractor or a lead participant/major shareholder in a joint venture contractor is a contractor on the List of Approved Contractors for Public Works in Group C for Buildings Category; and
- (b) The contractor or any one of the participants/shareholders in a joint venture contractor must have completed at least one 'qualifying contract'. Qualifying contract means building contract (in Hong Kong or any place outside Hong Kong) with an adjusted original contract sum not less than HK\$150 million with building services installations (including plumbing and drainage) not less than HK\$20 million and the substantial completion date within the past 10 years counting from and including the original date set for the close of tender (i.e. between 8 February 2010 and 7 February 2020). Only such contracts with substantial completion date falling within the above stated period will be considered.

Contractors not yet on the above-mentioned approved list/category/group may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category/group by 24 December 2019 to Chief Project Manager 302 of Project Management Branch 3, Architectural Services Department, 37th Floor, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications

and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Details for making the application are available at:—
