

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SD/2019/03, Wan Chai Development Phase II—West Landscaped Deck and Other Roadworks**. The works comprise construction of the West Landscaped Deck at the west of Hong Kong Convention and Exhibition Centre, road works at the junction of Tonnochy Road and Harbour Road, road improvement works at the junction of Hung Hing Road and Marsh Road, construction of coach park and associated works at Wan Shing Street, demolition works at Golden Bauhinia Square, and other associated road works, drainage and landscaping works. The works are scheduled to commence in the second quarter of 2020 the earliest and will take about 45 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box, situated at the Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 3 April 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 3 April 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 3 April 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors not yet on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 17 March 2020 to Chief Engineer/South 4, South Development Office, Civil Engineering and Development Department on 6th Floor, South Tower, West Kowloon Government Offices, 11 Hoi Ting Road, Yau Ma Tei, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
