Foreshore and sea-bed affected

Approximately 6 020 square metres of foreshore and sea-bed situated at Lei Yue Mun as delineated and shown edged red on a plan, numbered KM7337, deposited in the Land Registry, will be affected by the works to be carried out under the project. The actual area of foreshore and sea-bed (shown stippled black on the same plan) to be reclaimed under the project is about 842 square metres.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

Construction of a public landing facility. Works involve seawall and breakwater construction, dredging of sea-bed, rock excavation, pile construction and backfilling behind the seawall. Personal Information Collection Statement
