

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 3187EM19T, Triennial Term Contract for Replacement, Alterations, Additions and Improvement Works of Electrical, Mechanical and Air-conditioning Fitting-out at Various Disciplined Services Venues**. The scope of the Works includes fitting-out, replacement, alteration, addition and improvement works of Electrical, Mechanical and Air-conditioning installations for various disciplined services venues in Hong Kong. The Contract is scheduled to commence in September 2020 for expiry in July 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 26 June 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
