PROPOSED SOUTH EAST ASIA—JAPAN 2 CABLE SYSTEM—
HONG KONG SEGMENT (SJC2-HK)
FROM CHUNG HOM KOK TO THE EASTERN BOUNDARY OF
THE HONG KONG SPECIAL ADMINISTRATIVE REGION

Notice is hereby given that the undertaking described in the Schedule below is proposed. Any person who considers that he has an interest, right or easement in or over the foreshore and sea-bed so described may, by notice in writing delivered to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of two months from the date of this notice, object to the proposed undertaking. The notice of objection shall describe the interest, right or easement of the objector and the manner in which he alleges he will be affected.

SCHEDULE

Foreshore and sea-bed affected

Approximately 1.87 hectares of foreshore and sea-bed from Chung Hom Kok to the eastern boundary of the Hong Kong Special Administrative Region (HKSAR), as delineated and shown by a bold red line on a plan, numbered HKM10503, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Installation of an optical fibre submarine cable of approximately 37.5 kilometres in length and 47 millimetres in diameter. A cable-laying barge will be employed to simultaneously lay and bury the submarine cable in a trench of about 0.5 metres in width at a target burial depth of about 5 metres below the sea-bed. For the cable section near the shore, the cable will be installed by divers and protected by articulated pipe.
- (ii) At the crossing with an existing gas pipeline, the proposed cable will be laid by either the burial tool or divers at a depth of about 1 metre below the sea-bed and over the gas pipeline, for a section of approximately 200 metres to avoid any interference. Additional cable protection by 'Urduct' will be employed.
- (iii) Where the proposed cable crosses with the existing submarine cables, a shallower burial depth up to about 3 metres below the sea-bed, where possible, and over the existing cables will be adopted. The actual burial depth will be subject to the actual depth of the existing cables.

The area of foreshore and sea-bed affected is shown on the plan on the next page for identification purposes only. The area is more particularly shown on the plan numbered HKM10503 above referred to.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 6(2) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
