Foreshore and sea-bed affected

Approximately 183 square metres of foreshore and sea-bed situated at the Shek O Headland Picnic Area as delineated and shown edged red on a plan, numbered HKM10592, deposited in the Land Registry. Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

The reinstatement works include removal of the existing damaged footings and in-situ reinstatement of the Blue Bridge in order to restore its original appearance as far as technically feasible and resume access to the Shek O Headland Picnic Area. The proposed deck structure, covering an area of approximately 94 square metres above the sea, will be supported by columns and footings.
