PROPOSED REINSTATEMENT OF SHEK O BLUE BRIDGE
AT SHEK O HEADLAND PICNIC AREA

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 1151 published under section 5 on 13 and 20 March 2020 was authorized under section 7 on 5 June 2020.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 183 square metres of foreshore and sea-bed situated at the Shek O Headland Picnic Area as delineated and shown edged red on a plan, numbered HKM10592, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

The reinstatement works include removal of the existing damaged footings and in-situ reinstatement of the Blue Bridge in order to restore its original appearance as far as technically feasible and resume access to the Shek O Headland Picnic Area. The proposed deck structure, covering an area of approximately 94 square metres above the sea, will be supported by columns and footings.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes.
