Specified nomination forms may be obtained free of charge during ordinary business hours on any day other than a general holiday from the offices of the Returning Officers at the above addresses, or from the Registration and Electoral Office at 10th Floor, Harbour Centre, 25 Harbour Road, Wan Chai, Hong Kong or Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon, or can be downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>). Specified nomination forms may also be obtained free of charge from District Offices.

The election for each of the above geographical constituencies will be held on 6 September 2020. If the number of validly nominated candidates for any geographical constituency exceeds the number of Members to be returned for that constituency, a poll will be held on 6 September 2020 for that geographical constituency.
