A nomination for the candidate(s) of each of the above constituencies (other than the District Council (second) functional constituency) must be completed in the specified form and submitted by the nominated candidate **in person** (except where the Chief Electoral Officer has, on application, authorized any other manner of submission) and received by the Returning Officer for the functional constituency concerned at the above address (if the address of Returning Officer is at the Central Government Offices, the candidate should submit the nomination form in person at G/F, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong). For the District Council (second) functional constituency, a nomination must be completed in the specified form and submitted by one of the candidates on the nomination list **in person** (except where the Chief Electoral Officer has, on application, authorized any other manner of submission) and received by the Returning Officer of the District Council (second) functional constituency at the address of that Returning Officer. The nomination form must be received by the Returning Officer for the functional constituency concerned during ordinary business hours (i.e. from 9:00 a.m. to 5:00 p.m. from Monday to Friday and from 9:00 a.m. to 12:00 noon on Saturday) from 18 July 2020 to 31 July 2020 (both days inclusive other than a general holiday).

Specified nomination forms may be obtained free of charge during ordinary business hours on any day other than a general holiday from the offices of the Registration and Electoral Office at 10th Floor, Harbour Centre, 25 Harbour Road, Wan Chai, Hong Kong or Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon, or from the offices of the Returning Officers at the above addresses, or can be downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>). Specified nomination forms may also be obtained free of charge from District Offices.

The election for each of the above functional constituencies will be held on 6 September 2020. If the number of validly nominated candidate(s) for any functional constituency exceeds the number of Member(s) to be returned for that constituency, a poll will be held on 6 September 2020 for that functional constituency.
