

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1334EM20T, Triennial Term Contract for Building Services Fitting-Out Works, Replacement and Improvement Works to Health Sector Venues in New Territories West Region**. The scope of the Works includes building services fitting-out works, replacement, addition, alteration and improvement works in hospitals, clinics and venues operated by Hospital Authority and Department of Health in New Territories West Region. The Contract is scheduled to commence in December 2020 for expiry in November 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f on the 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 7 August 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.
