

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1897EM20T—Triennial Term Contract for The Maintenance and Repair, Alteration and Additions to Fire Service Installations in Venues in Hong Kong Island and Island (South) for the Government of the HKSAR.** The scope of Works shall include maintenance, repair, alterations and additions to the fire service installations at Venues in Hong Kong Island and Island (South) for the Government of the HKSAR. This Contract is scheduled to commence in February 2021 for expiry in January 2024.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor of the Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 31 July 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 31 July 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
