

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2020/03—Drainage Maintenance and Construction in Hong Kong Island and Islands Districts (2021-2025) and Building and Civil Maintenance and Minor Works to DSD Plants and Facilities (2020-2025)**. The works include the maintenance and improvement of public sewers and stormwater drains and the construction of minor drainage and sewerage works in Hong Kong Island and Islands districts which are scheduled to commence in December 2021 for completion in November 2025. The works also include the building and civil maintenance and minor works at sewage treatment works, pumping stations, storage tanks, rising mains, other plants and facilities, tunnels and submarine outfalls of Drainage Services Department which are scheduled to commence in December 2020 for completion in November 2025.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 14 August 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 14 August 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 14 August 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C for Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C under Roads and Drainage Category, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

The tenderer has completed at least one (1) relevant construction contract involving roads and/or drainage and sewerage works within the past ten (10) years, counting from the original date set for the close of tender, in Hong Kong or elsewhere outside Hong Kong, with adjusted value of such works not less than HK\$ 150 million. The adjusted value shall be the awarded contract value of relevant works being adjusted to current price level as stipulated in the tender documents. In the case of tender submitted by a joint venture tenderer, all participants or shareholders of the joint venture tenderer shall be collectively assessed as one entity as specified in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C for Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Friday, 31 July 2020 to Chief Engineer/Hong Kong and Islands, Hong Kong and Islands Division, Operations and Maintenance Branch, Drainage Services Department at 23rd Floor, 1063 King's Road, Quarry Bay, Hong Kong and meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.

A charge will be levied for the delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
