

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1737EM20T—Triennial Term Contract for the Comprehensive Maintenance and Repair of Lift Installations at Central Government Offices, Chief Executive's Office and Legislative Council Complex, Tamar.** The scope of the works includes comprehensive maintenance and repair of lift installations at Central Government Offices, Chief Executive's Office and Legislative Council Complex, Tamar. The Contract is scheduled to commence in January 2021 for expiry in December 2023.
