

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2019/04 Site Formation and Infrastructure Works near Tsz Tin Road and Hing Fu Street in Area 54, Tuen Mun**. The works include formation of about 3 hectares of land for public housing and school development, construction of road works, drainage works, waterworks, footpaths, slopes, retaining walls, vertical noise barriers, landscaping works and other ancillary works. The works are scheduled to commence in December 2020 and will take about 42 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 4 September 2020. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 4 September 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 4 September 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors on the List of Approved Contractors for Public Works in Group B under the Category of Site Formation or Roads and Drainage or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group B under the Category of Site Formation or Roads and Drainage who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant or the major shareholder in case of a joint venture tenderer, has completed in or outside Hong Kong at least 1 site formation contract with an adjusted contract sum of not less than HK\$130 million in the past 10 years counting from the original date set for the close of tender. The adjusted contract sum shall be the awarded contract sum being adjusted to current price level as stipulated in the tender documents

Contractors not yet on the List of Approved Contractors for Public Works in Group B under the Categories of Site Formation and/or Roads and Drainage may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 4 August 2020 to Chief Engineer/Land Works, Land Works Division, Civil Engineering and Development Department at 2nd Floor, Civil Engineering and Development Building, 101 Princess Margaret Road, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. Contractors will be liable to have their names removed from the approved list(s) if they fail or refuse to implement an accepted tender.
