

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1232EM20T, 15-Month Term Contract for Repairs, Operation and Maintenance to Boilers, Hot Water Installations, Steam Related Equipment and Accessories in Various Healthcare Institutions in the New Territories and Municipal Buildings of the Government of the Hong Kong Special Administrative Region**. The scope of the Works includes repair, operation and maintenance to boilers, hot water installations, steam related equipment and accessories in various healthcare institutions in the New Territories and municipal buildings of the Government of the Hong Kong Special Administrative Region in Hong Kong. The Contract is scheduled to commence in January 2021 for expiry in March 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 4128f on the 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 21 August 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.
