### Foreshore and sea-bed affected

Approximately 787 sauare metres foreshore and sea-bed situated at Kwun Tong Tsai Wan (Yau Tong Bay) as delineated and shown edged red on a plan, numbered KM10356, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- Construction of one flight of landing steps along the existing seawall at Kwun Tong Tsai Wan (Yau Tong Bay), which involves modification, demolition and reconstruction of the existing seawall and related works.
- Erection of a temporary works area at Kwun Tong Tsai Wan (Yau Tong Bay) to facilitate the proposed works.
