

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2985EM19T—Triennial Term Contract for the Maintenance of Electrical and Mechanical Installations at Tuen Mun Children and Juvenile Home and Miscellaneous Equipment in Premises in New Territories Region**. The scope of the Works includes maintenance, repair, alterations and additions of electrical and mechanical installations at Tuen Mun Children and Juvenile Home and Miscellaneous Equipment in Premises in New Territories Region. The Contract is scheduled to commence in December 2020 for expiry in November 2023.

Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
