(Notice of authorization under section 9)

PROPOSED H2H EXPRESS (H2HE) SUBMARINE CABLE FROM
CHUNG HOM KOK TO THE EASTERN BOUNDARY OF THE
HONG KONG SPECIAL ADMINISTRATIVE REGION

It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 3340 published under section 5 on 19 and 26 June 2020 was authorized under section 7 on 24 August 2020.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the Gazette, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

SCHEDULE

Foreshore and sea-bed affected

Approximately 1.17 hectares of foreshore and sea-bed from Chung Hom Kok to the eastern boundary of the Hong Kong Special Administrative Region, as delineated and shown by a bold red line on a plan, numbered HKM10565, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Installation of a submarine optical fibre cable of approximately 37.4 kilometres in length and 40 millimetres in diameter.
- (ii) The major part of the submarine optical fibre cable will be buried by a cable-laying barge using cable injector burial tool/sledge tool, in a trench of approximately 0.3 metres in width, at a target installation depth of approximately 5 metres below the sea-bed.
- (iii) On the sandy beach foreshore area between the lines of the High Water Mark and the Low Water Mark, the cable will be buried using small tracked diggers and hand held equipment, in a trench of approximately 2 metres in width, at a target installation depth of approximately 2 metres.
- (iv) From the line of the Low Water Mark to approximately 300 metres from the Beach Manhole, the submarine optical fibre cable will be buried by divers in a trench of approximately 2 metres in width, at a target installation depth transitioning from approximately 2 metres below the Low Water Mark to approximately 5 metres below the sea-bed at the point where a cable-laying barge can be used (in approximately 5 metres water depth).
- (v) Where the submarine optical fibre cable needs to cross the existing telecommunications cables, it will involve either shallow burial or surface lay, subject to the as-built burial depth of the existing cables and taking due care to ensure the integrity of all cables and their normal operation.
- (vi) Where the submarine optical fibre cable crosses the existing gas pipeline, it will be surface laid and/or shallow buried for a distance of approximately 100 metres from either side of the crossing point to avoid any interference. Additional cable protection by 'Uraduct' will be employed for a distance of approximately 50 metres from either side of the crossing point.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Director of Lands in connection with any written claims served under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is obligatory. If such information, including the personal data, as required under section 12(1) of the Foreshore and Sea-bed (Reclamations) Ordinance (Chapter 127) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
