

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2020/04 Greening Works in North District and Tai Po (Public Works Programme Item No. 5052CG)**. The works include planting and establishment of trees and shrubs; construction of associated planters and landscape works; and ancillary works including irrigating facilities. The works are scheduled to commence in December 2020 and will take about 30 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in Public Works Tender Box located in Room 503 on the 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 9 October 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 9 October 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 9 October 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors on the List of Approved Contractors for Public Works Groups A or B under Category of Roads and Drainage or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Groups A or B under Category of Roads and Drainage who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participant/shareholder in case of a joint venture tenderer, has completed in the past 5 years at least 1 roads and drainage works contract in or outside Hong Kong with an adjusted contract sum of not less than HK\$30 million and at least 1 construction contract involving landscape works in or outside Hong Kong.
