

It is hereby notified that sealed tenders in duplicate are invited for the **Contract No. 1435EM20T—Triennial Term Contract for Operation and Maintenance of Electrical, Mechanical and Other Installations at Kai Tak Cruise Terminal, Government Dockyard and Marine Ferry Terminals of The Government of the Hong Kong Special Administrative Region**. The scope of the Works includes operation, maintenance, alteration, addition and improvement of electrical, mechanical and other installations at Kai Tak Cruise Terminal, Government Dockyard and Marine Ferry Terminals of The Government of the Hong Kong Special Administrative Region. The Contract is scheduled to commence in March 2021 for expiry in February 2024.

Tenders must be marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at Lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 9 October 2020. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 9 October 2020, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon, on Friday, 9 October 2020, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
