This Notice was affixed to the above-mentioned land on 4 September 2020. Upon expiration of the notice period at midnight on 4 December 2020, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 5 December 2020.
