

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1717EM20T, Triennial Term Contract for Replacement, Alterations, Additions and Improvement Works of Building Services, Electrical, Mechanical and Air-conditioning Fitting-out at Various Correctional Services Department Venues**. The scope of the Works includes fitting-out, replacement, alteration, addition and improvement works of Building Services, Electrical, Mechanical and Air-conditioning installations for various Correctional Services Department venues in Hong Kong. The Contract is scheduled to commence in February 2021 for expiry in January 2024.

Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.
