BACKGROUND

(a) The works under the machine-room-less (MRL) lift nominated sub-contract comprises the supply and installation of a total of fourteen (14) electric MRL passenger lifts, including a two-year maintenance period following the certified sectional completion dates of the building contract for construction of transport infrastructure works and a water feature park, which consist of 9 nos. of 900kg; 1 nos. of 1,350kg and 2 nos. of 2,000kg, all at 1.0m/s.

PRE-QUALIFICATION CRITERIA

- (a) Contractors applying for pre-qualification shall meet the following criteria:
 - Being on the HA List of Lift and Escalator Contractors (Group L Lift) and not being restricted or suspended from tendering or removed from the list(s) when being considered for admission to the pre-qualified tenderers list; these requirements will also be adopted at the time of tender invitation, tender return and tender assessment;
 - ii Not having received more than one "Adverse" reports for all their current and completed HA projects in the past one year before approval of pre-qualification as stipulated in the invitation letter for pre-qualification;
 - iii Having experience in the supply, installation, testing, commissioning and maintenance of MRL lifts of rated capacities of 900 kg, 1,000 kg, 1,350 kg and 2,000 kg, all at rated speed of 1.0 m/s or above;
 - All MRL lift materials and equipment proposed shall have proven reliability and in-service records as stipulated in the updated HKHA Specification Library 2018 Edition;
 - No additional financial vetting is required at the pre-qualification stage as the contractors are to be pre-qualified from the HA List of Lift and Escalator Contractors (Group L – Lift) which are subject to regular financial vetting;
 - vi. Not being imposed any regulatory action by HA for works of similar nature when being considered for admission to the pre-qualified tenderers list; these requirements will also be adopted at the time of tender invitation, tender return and tender assessment; and
 - The contractors must possess valid ISO 9001 Certificates with scope of certification covering design, supply and installation and maintenance of lifts:

TENDER ARRANGEMENT

(a) The tender for the MRL Lift installation nominated sub-contract will be issued in December 2020 through pre-qualification tendering.

INVITATION FOR PRE-QUALIFICATION

- (a) All eligible contractors on the HA List of Lift and Escalator Contractors (Group L Lift) are invited for pre-qualification.
- (b) When expressing interest to submit tenders, contractors are required to submit details of supply and installation of MRL lifts of 900 kg, 1,000 kg, 1,350 kg and 2,000 kg, all at rated speed of 1.0 m/s or above, with in-service records to demonstrate they can fulfill with the pre-qualification requirement.
- (c) Since all contractors involved in this pre-qualification exercise are contractors on the HA List of Lift and Escalator Contractors (Group L – Lift), all requirements (i.e. related company restriction, tender irregularity restriction, probity requirement, etc.) set out in HA's Guide to Registration of Works Contractors and Property Management Services Providers are applicable to this pre-qualification exercise.
- (d) The contractors are required to confirm in writing their acceptance of the 'tender irregularity restriction' when accepting pre-qualification invitation.
