ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

NORTH APRON AREA OF KAI TAK AIRPORT DEMOLITION OF THE
EXISTING PASSENGER TERMINAL BUILDING AND
MULTI-STOREY CARPARK OF THE FORMER
HONG KONG INTERNATIONAL AIRPORT TERMINAL

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, vehicular bridges and pedestrian subway within the limit of works area as shown on Plan No. GZ/004 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 127 published on 10 January 2003 and 17 January 2003. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 1 October 2020 to 30 September 2021, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, vehicular bridges and pedestrian subway to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the demolition of ramps connecting the Multi-storey Carpark of the Former Hong Kong International Airport Terminal and an existing Subway SW1 (Part) near the Passenger Terminal Building of the Former Hong Kong International Airport Terminal; and ancillary works including associated drainage and landscaping works.

This notice will be affixed on or near the affected carriageways, footpaths, vehicular bridges and pedestrian subway on 11 September 2020.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means,

before the expiration of one year from the date of closure, extinction, modification or restriction:—
