It has been brought to my attention that **a building has been erected** on the above lot without having first obtained from me the approval of building plans and consent for the commencement of building works for the said building required by section 14 of the Buildings Ordinance. For the purpose of identification, the location of the said building is shown hatched-black on the plan annexed hereto.

2. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to demolish the said building described in the first paragraph.
3. You are required under the Buildings Ordinance to appoint an Authorized Person (architect/engineer/surveyor) to co-ordinate the works required in paragraph 2 above by:
 - (a) Submitting demolition proposal to the Building Authority for agreement before commencement of any works; and
 - (b) Upon completion, certifying that the agreed works have been carried out in accordance with the provisions of the Buildings Ordinance and regulations made thereunder.
4. You are required under the Buildings Ordinance to appoint a Registered Specialist Contractor in the demolition category to carry out the works, and an Authorized Person to advise on the necessary safety measures and to ensure the provision of those measures.
5. You are required to commence the works ordered by me in paragraph 2 above within 90 days and complete such works within 180 days of the date of this order, all to the satisfaction of the Building Authority.

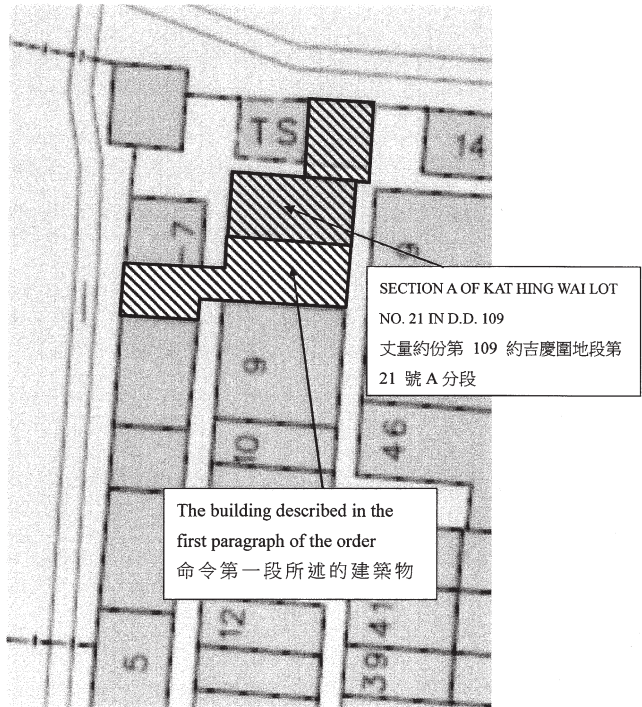
